Summary Narrative

On Tuesday, November 2, 2010 at 0943 hours, DFW/DPS Officers were dispatched to the Grand Hyatt Hotel in Terminal D in reference to an unconscious person. On Arrival, Officers met with two members of the hotel staff who stated they went to a room in the hotel to conduct a "welfare check" of the hotel guest because the guest did not answer his wake-up call. When there was no response to the knock on the door, the hotel employees entered the room and found the guest deceased. An investigation was conducted at the scene by DFW Airport EMS, CID, a Crime Scene investigator and the Tarrant County Medical Examiners Office. The body was removed and will be transported to the Tarrant County Medical Examiners Office for a determination of the cause of death.

Narrative

On Tuesday, November 2, 2010 at 0943 hours Officer P. Scavetta #492 and I (Officer P. Herring #697) were dispatched to the Grand Hyatt Hotel (room #324) in Terminal D in reference to an unconscious person. On arrival, Officer Scavetta and I met with two members of the hotel staff identified as Isacc [REDACTED], W/M, dob [REDACTED] and Crystal [REDACTED], W/F, dob [REDACTED]. Mr. Ambriz stated he and Ms. Montero went to room #324 in reference to a "welfare concern" because the guest, who was later identified as Philip Andrew Irons, W/M, dob [REDACTED], HI driver's license [REDACTED] failed to answer his wake-up call. When Mr. Irons failed to answer the knock on the door, Mr. Isacc and Ms. Montero entered the room and found Mr. Irons lying on his back on the bed. Mr. Irons did not exhibit any signs of life. Mr. Isacc and Ms. Montero then contacted DFW/DPS.

DFW Paramedics Gonzales #816, Patton #659, Adams #473 and Watson #714 arrived and examined Mr. Irons.

Narrative

Paramedic Gonzales conducted a cursory examination of Mr. Irons and determined that rigor mortis had set in. The Paramedics requested a representative of the Tarrant County Medical Examiners Office be sent to the scene.

CID investigators Sergeant Woodward #572 and Det. Bollon #733 arrived and conducted an investigation of the scene. Two prescription medications (Alprazolam and Zolpidem) were found in the room. The investigation showed that Mr. Irons arrived at DFW on 11-01-10 at 0630 hours from Miami on American Airlines flight #495. He checked in to the Grand Hyatt at 0847 hours on 11-01-10. The investigation also showed the last time the key to Mr. Irons room was used was 11-01-10 at 0859 hours.

Officer Goodson #639 conducted a crime scene investigation of the scene and will prepare a Crime Scene report.

Investigator Larry Steffler of the Tarrant County Medical Examiners Office arrived and conducted an investigation. Investigator Steffler examined the body and was unable to determine a cause of death. The body was released for transport to the Medical Examiners Office to Wilburn Lawson and D. Williams of Lawson, Inc. who have a contract with the Medical Examiners Office for body removal. Mr. Irons' personal effects and medication were released to the Tarrant County Medical Examiners Office. Room #324 was released back to the Grand Hyatt personnel.

Voluntary Statements were taken from Mr. Isacc and Ms. Montero and will accompany this report.

Narrative

On 11/02/2010, at approximately 1024 hours, I (CSI Goodson ID#639) responded to the Grand Hyatt as Crime Scene per Officer P. Herring #697).

Upon arrival, I met with Officer Herring at room 324. Officer Herring stated hotel personnel discovered a w/m deceased during a wake up call welfare check.

I then took control of the scene and had Officer J. Torres ID#862 remain at the entrance to the room and document the names of all persons that had entered prior to and after our arrival.

Observation of the room revealed it to be empty of all Police and EMS personnel. I observed a prescription bottle of Alprazolam (Xanax) dated 10/26/10 on the main table of the bedroom and a prescription bottle of Ambien dated 10/26/10 on the bed side dresser table. I also observed an empty bottle of Avion water on the floor next to the bed side dresser. Other items observed in the room were a black back pack, two shirts, a pair pants, socks and shoes, a grey jacket, ipod with ear piece attached, room key, empty soft drink cans, and an empty Reeses peanut butter cup package. I was unable to locate any suit cases or bags in the room.

Observation of the bed revealed a w/m lying on his back with the sheet pulled up to his neck. The bed covers and pillows were neatly set and nothing appeared out of the ordinary.

I then checked the door and locks for any signs of forced entry but did not locate any. Observation of the rest of the room did not show any signs of struggle. I was able to locate a wallet in the black back pack and discovered a

HI DL [REDACTED] belonging to Philip Andrew Irons, W/M, dob 07-24-78. The picture on the DL resembled the person lying in the bed. I also observed several credit cards and cash in the wallet.

Using a Canon 50D, I photographed the entire scene including the body and bar refrigerator. Tarrant County Examiner Larry Steffler arrived on scene at 10:51am. Mr. Steffler processed the scene and had the body removed. While the body was being removed from the bed, I photographed the side and back of the body. Mr. Steffler collected all personal belongings of the w/m and took them with him.

The photo log and a CD-R disc containing the photographs were packaged and submitted as evidence.
